



AAMC MEMBERSHIP CLASSES:

FULL – For a municipal clerk, deputy clerk or individual under the supervision of a clerk who performs at least 4 of the following 8 typical duties.

- General Management
- Records Management
- Elections
- Meeting Administration
- Human Resource and/or Financial Management
- Management of by-laws, articles of incorporation, ordinances or other legal instruments
- Custody of the official seal and execution of official documents

ASSOCIATE – For individuals who have an interest in the mission and purpose of AAMC who do not meet full member qualifications.

CORPORATE – For corporations, associations, or other business entities desiring to assist AAMC in the pursuit of its mission and purpose. *Awarded to businesses that sponsor the annual Clerk's Conference.

RETIRED – For individuals who have met full or associate member qualifications prior to retirement who desire to assist AAMC in the pursuit of its mission and purpose.

HONORARY – For past presidents of AAMC and/or individuals who have made a significant and exemplary contribution to AAMC and the municipal clerk profession. *This is a lifetime membership conferred by the executive board.
