- 7. NEW BUSINESS
  - A. Approval of the CY2020 Budget

President Peterson stated that the Executive Board previously approved the CY2020 Budget.

Allie Ferko (Valdez), seconded by Brenda Ballou (Seward), moved to approve the CY2020 Budget.

**Treasurer Trickey** provided a budget report to the membership. She stated it has been a difficult year for the Finance Committee and for the Executive Board. She shared that AAMC has been losing money on the annual conference every year since 2014 and explained that the conference venue has been increasing in cost each year. She thanked Betty Svensson with AML for negotiating on AAMC's behalf to help keep costs down. **Treasurer Trickey** stated that the Finance Committee prepared the budget to present to the Executive Board. She reported that the Committee considered a 30% increase to venue costs, which resulted in a \$24,000 draw from reserves. She stated that the Committee presented some cost-saving options to the Executive Board, and the Executive Board agreed to eliminate the three breakfasts for the academy and conference. She stated the Executive Board also voted to allocate annual scholarship budget funds based on the fundraising amount from the prior year. **Treasurer Trickey** shared that the current balance of the reserve fund is \$82,000, and AAMC will continue to look for ways to improve.

**President Peterson** called for a vote on the motion to approve the CY2020 budget. The motion carried without objection.

### 8. SPECIAL ORDERS / ELECTION OF OFFICERS

A. Election of Officers - Renee Krause, AAMC Election Chair

**Election Chair Krause** reported that the positions of Treasurer, Communications Director, and Second Vice President are up for election. She stated that April Trickey is the sole candidate for Treasurer, and Jamie Newman is the sole candidate for Communications Director.

**Election Chair Krause** called for objection to electing Ms. Trickey as Treasurer and Ms. Newman as Communications Director; no members objected.

**Election Chair Krause** reported that there were no candidates for the office of Second Vice President, and she called for nominations from the floor.

**Melissa Jacobsen** (Homer), seconded by **Jamie Newman** (Wasilla), nominated Brenda Ballou for the position of Second Vice President.

**Election Chair Krause** called for objection to electing Ms. Ballou as the Second Vice President; no members objected.

### 9. MEMBER COMMENTS

**Brenda Ballou** stated she is interested in an update on what the International Institute of Municipal Clerks (IIMC) is doing to develop another certification beyond the MMC. **IIMC Vice President Sheri Pierce** stated that the topic has been a priority for the IIMC Board of Directors over the last couple of years. She reported that the Board gave direction to form a task force to explore the idea. She stated that the task force is also looking at the CMC and MMC programs and current learning delivery methods. She stated the task force will report to the Board of Directors in May, and she will continue to support efforts towards an additional certification.

There were no further comments from the membership.

With no further business to come before the membership, **President Peterson** declared the meeting adjourned at 1:10 p.m.
