

AAMC MEMBERSHIP CLASSES:

PRIMARY – For a clerk, deputy clerk, assistant clerk, or clerk's office employee working in an office supporting a council or assembly in the State of Alaska.

CORPORATE – For corporations, associations, or other business entities desiring to assist AAMC in the pursuit of its mission and purpose. *Awarded to businesses that sponsor the annual Clerk's Conference. (*\$25 per year, \$50 for corporate members not sponsoring at the conference*)

RETIRED – For individuals who have met primary member qualifications prior to retirement who desire to assist AAMC in the pursuit of its mission and purpose. (*\$25 per year*)

LIFETIME – Requested by past presidents and conferred upon past presidents who have retired. (*no cost*)

HONORARY – For an individual who has made a significant and exemplary contribution to AAMC and to the profession of municipal clerk. *One membership may be awarded per year and is conferred by the executive board. (*no cost*)
