Welcome to the Alaska Association of Municipal Clerks (AAMC).



The 2021 Clerk of the Year (COTY) award was presented to the City of Sitka's City Clerk and former AAMC President, Sara Peterson, MMC, during it's 2021 Annual Conference Banquet.

Below are remarks prepared by COTY Committee Chair Melissa Jacobsen when presenting the award to Sara.

This year's awardee was recognized for her dedication in all facets of the role of the municipal Clerk. The letters of support provided by her Manager, Mayor, and co-workers all speak of her

leadership, knowledge of meeting process, strong communication skills, and dedication to her community.

Her manager describes her as an advocate for continuing education for herself and her subordinates. She's a caring mentor and has mastered the balance of personal and professional relationships with those she leads. Her office runs efficiently as she guides her team with an emphasis on public service first.

Fellow Clerks recognize her contributions to furthering the municipal clerk profession through her many years of service on AAMC committees and on the executive board. As AAMC President she focused on providing education sessions requested by the membership through input from conference surveys.

She was nominated by her former Deputy Clerk who speaks of her in the highest regard. Her co-workers talk of her efforts toward positive political discourse that may not have been achieved without her dedication to ensuring her community's public meetings are both as civil and public as possible. The Certified Municipal Clerk (CMC) program is designed to enhance the job performance of the Clerk in small and large municipalities. To earn the CMC designation, a Municipal Clerk must attend extensive education programs. The CMC designation also requires pertinent experience in a municipality. The CMC program prepares the applicants to meet the challenges of the complex role of the Municipal Clerk by providing them with quality education in partnership with institutions of higher learning, as well as State / Provincial / National Associations. The CMC program has been assisting clerks to excel since 1970.

The Master Municipal Clerk (MMC) program is the second and more advanced of the two professional designations granted by IIMC. The MMC program is an advanced continuing education program that prepares participants to perform complex municipal duties. The program has an extensive and rigorous educational component and a professional contribution component. The MMC applicant must demonstrate that they have actively pursued education and professional activities.

What to expect when you file for office

Verifying Eligibility of Candidates

The Elections Committee shall verify with the Membership Committee that those who have declared meet the qualifications of Article IV, Section 2, Eligibility for Office, of the AAMC Bylaws.

The Elections Committee shall provide the list of the qualified candidates to the Executive Board by their September meeting.

Preparation of Ballot

The Elections Committee shall prepare the ballot with the names of all qualified candidates for office. The ballot shall provide a space for a "write-in" vote for each office; provided, however, that the eligibility provisions for write-in candidates shall apply.

Notification of Membership

The candidate information shall be made available to the membership by e-mail and posted to the AAMC website no later than September 15. The information packet shall contain:

- · declaration of candidacy; and
- candidate statements; and
- photo (if provided).

Each candidate on the ballot shall be notified by the President or designee of the election results. If a write-in candidate is elected to any position and indicates a willingness to serve, the President or designee shall notify the candidate of the requirements set forth in Article IV, Section 1 and Section 4(b) of the AAMC Bylaws.

Municipal Clerks in Alaska serve as the Election Official in local elections and often assist the State of Alaska in the conduct of statewide elections.

The Alaska Association of Municipal Clerks (AAMC) is a professional organization dedicated to the education of municipal clerks statewide and to sound local government.

On April 27, 2022, AAMC adopted attached Resolution 2022-01, expressing its non-partisan, professional concern that altering the position of municipal clerk from an appointed position to an elected position would jeopardize the role of the clerk as a fair and impartial referee in elections and cause clerks to violate the state's conflict of interest law.

In the interest of preserving integrity in elections, the AAMC believes municipal clerks should adhere to the highest ethical standards as well as legal requirements.

ALASKA ASSOCIATION OF MUNICIPAL CLERKS RESOLUTION NO. 2022-01

A RESOLUTION SUPPORTING THE APPOINTMENT OF MUNICIPAL CLERKS IN ALASKA; URGING MUNICIPALITIES TO RETAIN THE APPOINTMENT OF THE MUNICIPAL CLERK; AND OPPOSING EFFORTS TO ALTER THE POSITION OF THE MUNICIPAL CLERK FROM AN APPOINTED OFFICIAL TO AN ELECTED OFFICIAL

WHEREAS, AS 29.20.360 calls for the appointment of the clerk as an officer of a municipality by either the chief administrator or by the governing body unless otherwise provided by ordinance, and

WHEREAS, AS 29.20.380 provides for the duties of the municipal clerk, which among many other responsibilities, requires the administration of all municipal elections, and

WHEREAS, AS.29.20.010 outlines that a municipal clerk could be in violation of the Conflict of Interest law by participating in the official action of conducting an election while appearing on the ballot, because that same municipal clerk could have a substantial financial interest in the outcome of the election -i.e., retaining the position, and

WHEREAS, AS 29.20.010 applies to home rule and general law municipalities, and

WHEREAS, AS 29.20.600, provides that the clerk, before taking office, shall take an oath to perform the duties of office honestly, faithfully and impartially, and

WHEREAS, according to the local government specialists in Division of Community and Regional Affairs, a sub-unit of the Alaska Department of Commerce, Community, and Economic Development, there are currently no elected municipal clerks in the State of Alaska, and

WHEREAS, the mission of the Alaska Association of Municipal Clerks is to provide for the continuing professional education of municipal clerks across the state and to promote sound local government,

NOW, THEREFORE, BE IT RESOLVED BY THE EXECUTIVE BOARD OF THE ALASKA ASSOCIATION OF MUNICIPAL CLERKS AS FOLLOWS:

Section One: The AAMC Board urges maintaining the position of municipal clerk in Alaska as an appointed official in order to retain the integrity and neutrality of the clerk in conducting elections.

Section Two: The AAMC Board opposes efforts to alter the position of municipal clerk in Alaska from an appointed official to an elected official for the legal and ethical reasons noted in the foregoing recitals and in Section One.

Effective Date of Resolution. This resolution will be effective the 27th day of April, 2022.



What made you decide to run?

I'd been serving on committees and as committee chair for quite a while and was also working toward my MMC certification. When the Communications Director seat came up for election I felt that was a good way to get my feet wet and see what serving on the executive board was all about, and also earn points toward certification. I was on my second term and one evening at an IIMC conference dinner we were sitting around the table, enjoying good food, wine, and company, then Shellie Saner leaned in and said she was going to run for 2nd VP that year. She encouraged a couple of us to plan to run in the consecutive years and we'd support each other along the way. Please describe a rewarding moment you had as a board member/president.

A rewarding time for me was working with AML to organize a regular weekly teleconference meeting time for Clerk's to call in and discuss challenges we were experiencing with the pandemic. We were immediately transitioning to virtual meetings on a variety of meeting platforms, dealing with how to provide notices and allowing for citizens to be heard. We were figuring out how to close buildings and still serve the public, or staying open and figuring out how to stay safe. And... how to safely and effectively conduct elections. It was a great way to share ideas, talk about what was working and what wasn't, share our fears and frustrations, and I felt that it helped us know we weren't alone in what we were going through at that time.

With the 2020 conference being canceled because of COVID-19, conducting our first virtual AAMC Annual Meeting was also extremely rewarding. There wasn't a guidebook for that but the Board worked together and we made it happen. I was so happy to see the membership connecting to Zoom and participating, and AAMC being able to get their work done!

What would you say to someone who is thinking about running, who might be on the fence, to encourage them to run?

Just do it! It's really rewarding to serve on an organization that gives so much back to its membership. You'll get an opportunity to learn how AAMC functions and help make decisions for its success. And it's a great way to form bonds with the other clerks you'll serve with, and be able to support each other while you're on the board and beyond!

There were times I'd have to do a little bit of work in my off time, after work or lunch breaks, to prepare for Board meetings and for the annual meeting. It was less frequent as Communications Director, those tasks come up on a routine basis, and it was easier to allocate time to do that work.



What to expect when you file for office

Verifying Eligibility of Candidates

The Elections Committee shall verify with the Membership Committee that those who have declared meet the qualifications of Article IV, Section 2, Eligibility for Office, of the AAMC Bylaws.

The Elections Committee shall provide the list of the qualified candidates to the Executive Board by their September meeting.

Preparation of Ballot

The Elections Committee shall prepare the ballot with the names of all qualified candidates for office. The ballot shall provide a space for a "write-in" vote for each office; provided, however, that the eligibility provisions for write-in candidates shall apply.

Notification of Membership

The candidate information shall be made available to the membership by e-mail and posted to the AAMC website no later than September 15. The information packet shall contain:

- declaration of candidacy; and
- candidate statements; and
- photo (if provided).

Each candidate on the ballot shall be notified by the President or designee of the election results. If a write-in candidate is elected to any position and indicates a willingness to serve, the President or designee shall notify the candidate of the requirements set forth in Article IV, Section 1 and Section 4(b) of the AAMC Bylaws.


