AAMC Executive Board has been busy over the past few months, here are some of the highlights:

- Reviewed and discussed the mission of AAMC.
- Solicited and appointed the vacant Secretary Office seat on the Board. Jamie Heniz, Municipal Clerk of Anchorage, was appointed by the Board in February. Thank you, Jamie, for your willingness to step up and serve AAMC in this compacity.
- Approved changes to the IIMC Region IX Director agreement to increase the annual contribution from \$5.00 to \$7.00 per member into an assessment pool to cover travel cost for the Region IX directors to attend state association conferences. This change was ratified by all Region IX State Associations.
- Approved a letter of support to nominate Joann Tilton, NCI Director for the IIMC Institute Directors Award of Excellence. We will find out if she is awarded this award in May at the IIMC Annual Conference. Stay tuned in!
- Reviewed conference registration fee refund policy and made changes that will help clarify the policy and provide better direction on how to request a refund.
- Discussed implementation on sending out electronic committee certificates and certificates of attendance to the AAMC annual conference. I am happy to report that this will be implemented for 2024.
- Approved NCI scholarships for three members to attend PD I, two members to attend PD II in June, as recommended by the Scholarship Committee.
- Approved to hold an in-person Athenian Dialogue on Wednesday, December 4, 2024, after the AAMC Annual Conference. More information to come soon, the Education Director is waiting patiently for me to pick a book for the Athenian dialogue.
- Reviewed the AAMC Fees for membership dues, annual conference, and advance academy and Athenian dialogue registration fees. Happy to report that there will be no fee increases in 2024.



President's Message Cont.

I know that many AAMC Committees are meeting and working on their objectives for the year and Planning Conference Committee is in full swing planning for the AAMC Annual Conference in December. December may seem like several months away but as you all know Clerks like to plan and be prepared because we never know what will be thrown our way and what we can get done today why put off to tomorrow when tomorrow our world could blow up.

I write that from experience what I had planned for this spring was changed by one vote of my Assembly and my team gets to hold a Special Election on May 7th. Did I tell you that candidate filing has not even opened, and I have four letters of intent filed for our Mayor's race in October, in which three of the candidates have already raised almost \$20,000 in campaign funds. I think FNSB might get to do a runoff election at the end of October. My office is looking at the possibility of three elections in one year, plus our normal service area elections.
